
#### **Encryption**

New functionality was added to enable you to define settings for log recording that can bypass the log recording settings defined for a Field Registry. Click on **User Log Recording Manager** in the Tasks Panel.



When the Policy Status is set to **Not Active**, the User Log Recording Manager is disabled and log recording is governed by the Log Recording setting in the Field Registry properties and the accounts defined in the Field Authority for that Field Registry. Set the Policy Status to **Active** to enable the User Log Recording Manager.

For the Include / Exclude mode, the following options are available:

**Include by list.** Logging is performed for all users in the list per the definition in the log recording setting for each field registry.

**Include all Users**. Logging is performed for all users per the definition in the log recording setting for each field registry (regardless of the list).

**Exclude by list.** No logging is performed for users in the list.

**Exclude all Users.** No logging is performed for any users.



#### Alerts

SEC-1109 The Add group right click option has been removed from the Alert types module.

SEC-1798 Alerts will now be generated when more than 45,000 files are journaled to a journal.

SEC-2671 The Account Swap drop down list now displays correctly.

### Compliance

SEC-997 The CRTTPLOBJA file can now contain a large number of compliance object authority templates. SEC-1096 The commands CRTTPLOBJA, DLTTPLOBJA and CHGTPLOBJA now correctly handle

System/System Group \*LOCAL.

#### **Data Providers**

### **Encryption**

SEC-869 When updating an existing Encryption Field Registry ID, the From and To positions of the field are now right-adjusted.

SEC-1053, 1059

Field Encryption, Field Security, Field Scrambling and Field Masking now support files with a binary field with a length of more than 9 positions. If a negative value is received for a user with Scrambled or Masked Field Authority, all 9's are written to the field in order to prevent execution errors.

SEC-1087 In all Encryption modules, if QTEMP is entered in the Encrypted File Library field, an error message states that the library is not supported. If any library beginning with Q is entered (other than QS36F), a warning message appears.

SEC-1889 Correction to masked view display of packed fields with leading zeros.

SEC-2250 All Encryption submodules now work correctly when more than 1000 field registries are defined.

SEC-2271 The Supported Field Type List tab was added to the Select Field dialog box, which displays the field types supported by the different Encryption modules.

SEC-2421 Field Scrambling of negative numbers for all binary fields will now appear as all 9's.

The Report Generator now correctly sends email for job CCSID 273.

SEC-1828	In the User Profile Report type, in the Special Authority not Matching User Class report (report 79), the correct values are now displayed in the Query - Advanced SQL Input window.
SEC-2173	In the Open Ports Report type, the Local Report field is now sorted correctly, the value of the System field is now set to the system name and a new field containing the serial number was added.
SEC-2243	The BRAUTGR field (group profile special authorities) was added to the Group Profiles Report type.
SEC-2338	The option to display the Home directory was added to the User Profile Report type.
SEC-2362	Performance improvement to the Firewall Report type.
SEC-2451	The System Audit (detailed) Report type now displays the program name correctly.
SEC-2794	In the File Audit Report type, when Central Audit File is selected as the Data Source, it is no longer necessary to enter a Journal name and library. (If a Journal name and library are entered, the data source will be the specified Journal name and library.)
